Release do not forget to report your income.

- What: There is the "income-based levy" (所得割/Shotoku wari) using your prior year's income for the national health insurance fee and the medical insurance fee for the elderly. If reporting your income is delayed, insurance fees may not be calculated correctly and result in an increase of insurance fees. Also, people who had no income or people who are not required to report their income under the tax laws (for example people only with non-taxable pension; suvivor's pension or disability pension) may see a reduction in their coming year's insurance fees if reported.

- What: There are allowances available to people with disabilities or those who care for people with disabilities. \$\text{Things to be careful when the warning is issued:}



★ Procedures when moving – Registration procedures ★

Please report your change of address within 14 days after moving!

Report your change of address within 14 days after moving. The contents will be registered in the Basic Resident Registration System and become valuable data which proves your address. We will introduce the necessary steps to take when moving. Don't forget to write the full name of the apartment. Things to bring other than your ID are as follows.

· Please help us when confirming your identity

To prevent false registration by another person, we check each person who comes to register the change of address (moving in or out), or family register (affiliation, marriage, divorce, adoption of child, dissolution). Please present several documents which will verify your identity at the time of registration. When a deputy submits the registration, the letter of attorney is necessary.

- Identification documents: A photo ID card issued by the government or other public offices.
 Examples are:
 - Driver's License
 - Passport
 - "My-number Card" (Individual Number Card)
 - Basic Resident Registration Card (with a photo)
- In case of registration for moving and applying for certificates, two of the following are also acceptable:
 - National Health Insurance Card
 - National Pension Handbook
 - Employee ID Card
 - Student ID Card
 - Bank Savings Passbook

Please prepare these documents when you come to apply for the following certificates

- Certificate of All Records of Koseki (Certificate of Family Register)
 - Identification (a letter of attorney if required if an applicant is not a lineal relative)
- Residence Certificate (Jumin hyo)

- Identification (a letter of attorney if an applicant is not in the same household)
- Seal registration certificate
 - Seal registration Card or Citizen Card with seal confirmation
- o Registration of birth, death, moving, etc. is required by the laws.

© Certificate Issuance service at Convenience Stores

Various certificates can be issued at multi-copy machines located in convenience stores all around Japan. To use this service, a My Number Card is required.

- The service cannot be used with a notification card, basic resident register card, or citizen card.
- Those who did not request the issuance of an electronic certificate for user certification when applying for or receiving their My Number Card cannot use this service.

Service for Non-Numazu City Residents

Certificates can also be issued mutually among the **12 cities and towns in the Sunzu area** (Numazu City, Atami City, Mishima City, Ito City, Gotemba City, Susono City, Izu City, Izu no Kuni City, Kannami Town, Shimizu Town, Nagaizumi Town, and Oyama Town).

- Available Services:
 - 1. Issuance of a residence certificate (Jumin hyo)

- 2. Issuance of a certificate of seal registration (Inkan Toroku Shomei sho)
- 3. Issuance of a certificate of all (personal) matters in the family register

Only the person themselves or members of the same household may access this service for issuance of residence certificate and certificate of seal registration.

Those who can use the service for issuing a family registry certificate (Koseki) are those who have their residence and permanent address in the 12 cities and towns of the Sunzu area. For details, please contact each city/town hall.

A residence certificate (without the registered domicile (Honseki)) can be issued at any city, town, or village in Japan using the Basic Resident Registration Network.

★ The announcement of Reiwa 3rd small car tax (based on classification) ★

• What: Small car tax is imposed on the owner on April 1st every year.

There is no monthly refund system even if you scrap a car or change the owner on or after April 2nd. Please finish the application of handing over, disposal or loss of motor bikes and small cars by the end of March.

Annual tax amount for light four-wheeled vehicles, etc.

The tax amount will be applied according to the inspection date of the first fiscal year (the year and month when the vehicle number was specified for the first time). A heavier tax will be imposed on vehicles whose first fiscal year inspection date is before March, 2009 in Reiwa 4 fiscal year.

The date of the first inspection is from April, 2021 to March,2022 and for vehicles with a small environmental load such as electric vehicles, the special green tax exception is applied only for Reiwa 4 fiscal year.

☆ Child Support Fund Interest Supply System for Workers ★

• **What:** The city will subsidize the interest for the salary workers living in the city to use the childcare support fund of the Shizuoka Labor Bank.

Use of fund	Childcare cost for preschool children
Credit limit per household	1 million yen per household (2 million yen if there are two or more children)
Interest rate	Within 2.0% per year (for 5 years)

• What: From March 1st (Tue) to 7th (Mon), the Spring National fire prevention campaign will be held. We should always be aware of fire and aim to live safely and securely.

10 points to prevent fire

4 Practices

- 1) Do not smoke while laying down.
- ② Use stoves where there are no combustible objects in the area.
- 3 Always turn off the gas stove when going away from the stove.
- 4 Clean sockets and remove unnecessary plugs.

6 measures

- ① Use equipment with a safety device for stoves, gas stoves, etc.
- ② Regularly check residential fire alarms and replace them every 10 years.
- ③ Keep rooms tidy and use flameproofing products for bed clothes, clothing and curtains to avoid fire.
- 4 Install a fire extinguisher and check how to use it.
- ⑤ Elderly people and people with disabilities should always secure and prepare evacuation routes and evacuation methods.
