% Extension of Injury and Sickness Allowance payout period in response to COVID-19 infections %

- What: The payout period for Injury and Sickness Allowance as a result of COVID-19 has been extended to December 31 (Sat).
- **Details:** This allowance is specific to those employees insured by National Health Insurance or Late-Stage Medical Care System for the elderly. It provides an allowance for the period in which the eligible person cannot engage in labor due to being infected by COVID-19.

What: Subsidizing part of the vaccination costs for people under the age of 18 who are going to be

※ J-alert's signal transmission will be conducted for drill **※**

- **What**: We will conduct a simulated signal transmission of J-alert which is the system of the national emergency warning. This system will be transmitted to citizens instantaneously by the public address system with early warnings of an earthquake, an armed attack etc.

※ Public Address System will be replaced by a digital system **※**

- What: On December 1 (Thu), in accordance with national radio laws and regulations, the public address system will be converted to a digital system. Outdoor broadcasting will continue as before, but disaster prevention radios will no longer be able to transmit the broadcast. The city has established an e-mail service and an automatic response system dialing system to confirm broadcast contents, and also provides disaster prevention information via the Disaster Prevention App, Line, Twitter, etc. Please use

% Please pay the city tax before the due date %

November and December are the non-payment consolidation months in Shizuoka Prefecture.

Not paying the city tax means inequality between people who paid the tax on time, so it might contribute to difficulties in providing services. This city actively works to reduce the amount of non-payment.

■If you did not pay the city tax

If you did not pay the city tax, overdue fine will be added at rate of 8.7% annually. If you continue to keep not pay the tax or without consulting the city office even after the reminder letter, you will be forced to pay the tax by law in the following order written on the right.

■To reduce the amount of non-payment

Recently, the number of compulsory collection has been increasing, especially in cases which investigates the salary and foreclose it. Also, we might go inside the house of the non-payer and investigate properties without permission.

XInvestigating the properties and foreclosure are done according to the law, and can be done without giving a notice the non-payer.

Process of the tax delinquency collection

Sending a Tax Delinquency Notice

A tax delinquency notice is sent to the delinquent taxpayers within 20 days after the due date. They have to pay another 50 yen for the issuance of a tax delinquency notice.

Investigation of Property

Information on the delinquent taxpayer's property is collected from interviews, inspections and searches in his/her workplaces, banks, life insurance companies or business partners.

Seizure of Property

Seizable properties include deposits and savings, salary, life insurance, account receivables and cars found during the investigation.

Realization, Dividend

Seized property will be converted into money by "collection" or "public auction". The money obtained from the conversion will be applied to the delinquency of municipal tax and its penalty etc.

<In the event that you can't pay.>

We will make a payment plan for you based on your living condition if you have any unavoidable circumstances such as diseases, disasters, unemployment, relinquishing of business, or unprofitable business operation that you can't pay tax by the due date. We have set up a nighttime consultation, so please contact us early.



Schedule of nighttime consultation

※ Fall national fire prevention campaign ※

What: From November 9 (Wed) to 15 (Tue), the Fall National fire prevention campaign will be held. We should always be aware of fire and aim to live safely and securely.

10 points to prevent fire

4 Practices

- 1 Do not smoke/do not let anyone to smoke while laying down.
- ② Use stoves where there are no combustible objects in the area.
- 3 Always turn off the gas stove when going away from the stove.
- 4 Clean sockets and remove unnecessary plugs.

6 measures

- ① Use equipment with a safety device for stoves, gas stoves, etc.
- ② Regularly check residential fire alarms and replace them every 10 years.
- 3 Keep rooms tidy and use flameproofing products for bed clothes, clothing and curtains to avoid the spread of fire.

- 4 Install a fire extinguisher and check how to use it.
- ⑤ Elderly people and people with disabilities should always secure and prepare evacuation routes and evacuation methods.
- (6) Take for prevention measures throughout the region by participating in fire prevention training. and individual visits by firefighting staff.

Information on the COVID-19 vaccination for Omicron strains

We have sent tickets for the 4th vaccination to people aged 12 to 59 who completed the 3rd vaccination by May. You can make a reservation when you receive it. We also have been carrying out a mass vaccination at Kiramesse Numazu from October 26. For the third and subsequent inoculations, the Pfizer vaccine corresponding the Omicron strain will be used. In addition, the supply of conventional vaccines for the 1st and 2nd doses from the government is scheduled to end December, so please consider taking them in a planned manner.
