♣ Influenza Vaccination

Influenza vaccines have been shown to be effective in preventing the severity of influenza. The epidemic season can by mixed up, let's consider early if you want to get vaccinated.

♣ If you have any symptoms...

If a person with symptoms such as fever visits a medical institution without notification, the infection may spread. If you feel any change in your physical condition, first consult with your family doctor or the Shizuoka Prefectural Consultation Centre for fever, etc (see the last page) by phone.

♣ Be aware of norovirus in winter

Here are some tips for prevention.

- Frequently wash your hands
- · Cook food sufficiently before eating
- Keep utensils clean
- Take measures to prevent secondary infection when handling the vomit of an infected person

Emergency Assistance Benefit for Electricity, Gas, Food, etc. Apply by Tuesday, January 31, 2023 (must arrive by this date)!

 What: Considering the increased burden caused by soaring prices of electricity, gas, and food, the program will provide ¥50,000 per household to households exempt from residential taxation to support their daily lives.

Eligibility for benefits and application			
1. Registered as a resident of Numazu City as of September 30 and all members of the household that are exempt from resident tax on a per capital basis for the 2022 fiscal year.	2. In principle, no application is required (only return of confirmation letter)	Application required		
Please note that a confirmation letter was mailed on November 16 (Wed) to all prospective applicants. Note: Households with a resident who moved in on or after January 2, 2022 will not receive a confirmation letter, so an application is required.	Application must be made to the city, ward, town, or village where you are registered at the time of application. Application forms are available on the city's website and are also distributed at a satellite city office.		

Notes:

- If all members of the eligible household receive support from relatives who are subject to residential tax, they are not eligible for the benefit.
- o If both 1 and 2 apply, priority will be given to 1 and no duplicate payments will be made.

Information on the vaccination of COVID-19

The vaccination interval for the Omicron strain vaccine has been shortened from 5 months to 3 months. In addition, vaccination of infants from six months to four years old has started. It is available to receive it at some medical institutions in the city. We are carrying out vaccinations for Omicron strain (BA.4-5) made by Pfizer. If you are interested, please consider getting vaccinated early in preparation for the possibility of an epidemic during the year-end and New Year holidays.
