## **✗** Issuing Vouchers for Usage of Indoor Heated Pools in Outside Cities **✗**

In conjunction with the city's indoor heated pool reconstruction, the city will partially subsidize the usage fee for the Numazu citizens using pools in other cities. The issuance of the Reiwa 6 (2024) vouchers began on Monday, March 25.

- Eligibility: Registered residents of Numazu city with either the Class 1/2 Physical Disability Certificate, Rehabilitation Notebook (ryo-iku techo) A, or the Class 1/2 Mental Disability Certificate (Excluding facility residents, hospitalized individuals, cars/ light motor vehicle tax-exempted individuals, and Going Out Support Services Users)
- Subsidy amount: The initial cost of a standard-sized taxi.

## **✗** Distribution of Hazard maps to every household! **✗**

In preparation for a potential eruption of Mt. Fuji, we created "Numazu, Mt. Fuji Volcanic Disaster Prevention Map", which will be distributed to each household starting from Friday, March 15.

■The maps can be found inside of the March 15 Newsletter (Koho Numazu, Japanese Version).

#### About Numazu, Mt. Fuji Volcanic Disaster Prevention Map

Due to updated damage prediction for Mt. Fuji eruption, Numazu city has been designated a volcanic hazard warning area (%1).

Following the update of evacuation plans by the Mt. Fuji Volcano Disaster Prevention Measures Council (%2), the hazard maps for Numazu were revised in March of Reiwa 5 (2023).

Please familiarize yourself with the potential volcanic phenomena and their impact resulting from predicted volcanic activity, and utilize this information to prepare proactively and plan for emergency evacuation.

\*1 Volcanic hazard warning areas indicate the recognized area where residents may be affected by the eruption.

\*2 Mt. Fuji Volcano Disaster Prevention Measures Council consists of administrative agencies in Shizuoka, Yamanashi, and Kanagawa prefectures; considering overall disaster prevention measures in the event of an eruption.

#### What are the effects of the eruption on Numazu?

#### Lava flows

The are 252 craters on Mt. Fuji, 10 of which affect Numazu City. 15 patterns of lava flows have been identified, with 1 pattern possibly reaching Numazu. Depending on the location and scale of the eruption, lava flows could arrive within a minimum of 18 hours and a maximum of 57 days.

#### Volcanic ash

Ashfall of 2 to 10cm is expected within the Numazu residential areas; they may disrupt vehicle operations.

1	Interpretation/Translation	Translation and interpretation for foreign students at schools, etc.

3	Host family	Acceptance of homestays for foreign visitors of the city's sister city and friendly city exchange program
4	Introduction to Japanese and foreign culture	Introduction of the culture of each country at city events, lectures, etc.
5	Support foreigners in the event of a disaster	Provision of information and consultation to foreign residents in the event of a large-scale disaster

#### Who:

- 1. People who can interpret and translate from foreign languages to Japanese and from Japanese to foreign languages.
- 2. People who understand and are willing to provide Japanese support to foreign residents.
- 3. In principle, a person who is not a part of a single-person household, and who can obtain the understanding and cooperation of his/her family.
- 4. People who can introduce the culture and cuisine of each country in Japanese.
- 5. People who understand and are motivated to support foreigners during disasters.
- Eligibility: Person who meets all of the following requirements.
  - People 18 years of age or older who live in the city or neighbouring municipalities (foreign nationals must have a residence status.)
  - People who are willing to volunteer.
  - People who can participate in training sessions, etc. conducted by the city.
  - A person who is not a member of an organized crime group as stipulated in the Numazu City Ordinance on Elimination of Organized Crime Groups



### **※ Forest Environmental Tax (National Tax) Begins ※**

Starting from Reiwa 6 FY, along with the residential tax per capita, there is a new requirement to pay 1,000 yen per person annually for the forest environmental tax.

From Reiwa 6 FY(2024), the total tax amount, including the residential tax per capita and the forest environmental tax, will be the same as the yearly tax for the residential tax in Reiwa 5 FY(2023) due to the completion of the 1,000 yen increase in the residential tax that was implemented for the basic act on reconstruction in response to the Great East Japan Earthquake.

The collected forest environmental tax will be transferred to the prefecture or the city as the forest environmental transferred



tax. This tax will be used for forest maintenance and other related purposes. We appreciate your understanding and cooperation with this new tax system.

### **※ Children with chronic specific diseases are provided with daily living aids ※**

The following equipment is provided for children with chronic specific diseases who have difficulty in living their daily lives at home, to support their daily lives (co-payment is required according to household income).

- O Toilet bowl, special mat, special toilet bowl, special bed, equipment for supporting to walk and bath, special urinal, position transducer, wheelchair, head protection cap, electric phlegm vacuum, cool vest, UV protection cream, nebulizer (inhaler), pulse oximeter, stoma appliance (digestive system), stoma appliance (urinary system), Nasal prosthesis

**Note:** Households, including those who moved in on or after January 2, 2023, need to submit an application by the deadline of May 31, Friday. Please ensure that the application documents arrive no later than the deadline.

### ★ Don't forget to register inheritances ★

From April 1, it has become mandatory to apply for inheritance registration of land and buildings. The heir must register the inheritance within three years from the day he/she learns that he/she has acquired ownership.

Please note that inheritances that occurred before April 1 are subject to this obligation.


