Submission deadline: Monday, March 16

*Please prepare documents that verify your income for Reiwa 7 (2025) and any certificates required to apply for deductions.

*A My Number Card and the passwords of digital certification of the bearer's signature and digital certification for proof of user are required.

Mail submission

Please refer to the "Municipal/Prefectural Tax Declaration guide(市民税・県民税申告の手引き)" that will be mailed to eligible individuals, and send the required documents by post.

Required documents: 1. Tax declaration form 2. A copy of your MyNumber Card or other identification documents 3. Documents that verify your income for the year Reiwa 7 (2025) 4. Certificates and other documents required to apply for deductions.

Submission deadline: Monday, March 16 (must arrive by this date)

✧ J-alert's signal transmission will conduct a drill ✧

- **What:** We will conduct a nationwide J-Alert transmission test. This system instantly transmits information such as early warnings of an earthquake, tsunami warnings, and ballistic missile attack etc. to citizens via public address system.

- **Details:** "This is a test for J-alert" (これはJアラートのテストです) will be repeated 3 times.
